

**Prizes: Guaranteed \$2000 for the biggest coyote of the hunt. Second Prize will be a \$400 gift certificate to Croasdale Sporting Goods. \$200 for the biggest coyote turned in each day. \$50.00 for each coyote turned in.** If you want to register for the largest female coyote contest, it will cost an extra \$2.00. All money collected for female registration will be paid back as prize money. Continuing this year, we will also be having a **Fox Hunt**. Entry is \$10. There will be a prize for largest red fox and largest grey fox. \$4 from entry will go into prize for largest red and \$4 will go into prize for largest grey. The club will keep the remaining \$2. **Must be registered for coyote hunt to be in fox hunt.**

All animals entered must be taken in the following counties to be counted: Bradford, Susquehanna, Wyoming, Wayne, Lackawanna, Pike, Luzerne, Sullivan, Carbon, Monroe, Tioga, Columbia, Lycoming, or Schuylkill

**Rules:**

1. All hunters must have a Pennsylvania Hunting License.
2. Hunt Dates: Friday January 21st at 12:01am to Sunday, January 23rd at 4:00pm 2022.
3. **Entry Fee: \$30 per person. Must be received No Later Than Thursday January 20<sup>th</sup> 2022. No exceptions.**
4. **All members** of a hunting party must be registered in this hunt or the entire party will be disqualified.
5. All coyotes must be checked in by 4:00pm on, January 23<sup>rd</sup>, 2022. Check in time will be from 12:00pm - 9:00pm on Friday, Jan. 21, 12:00pm - 9:00pm Saturday Jan. 22, and 10:00am - 4:00pm on Sunday, January 23, 2022.
6. Hunt Committee members reserve the right to refuse any entry, if they feel it was taken illegally or before time and date of hunt.
7. All Pennsylvania game laws apply, and no trapped coyotes are allowed.
8. Weigh-ins will be held at Endless Mountain Coonhunter's Club, in Springville, PA. The club is located off Route 29 South between Montrose and Springville. Signs will be posted.
9. Coyotes may be taken by calling or hunting only.
10. In case of tie, the first coyote weighed in, wins.
11. All coyotes entered must not have an internal body temperature lower than 65 degrees.
12. All the same rules apply to fox hunt

All coyotes entered may become the property of the Hunt Committee. **The hunter, who makes the kill, must present the coyote for registration.** The Hunt Committee may not award prizes for 72 hours after the hunt ends, to allow review of the animals and verification of rules compliance. An autopsy may be done on animals the Hunt Committee deems suspicious. By paying the entry fee, the hunter agrees that the decision of the Hunt Committee is final. Any infractions will result in immediate disqualification of the hunter(s) involved, and all prize monies and entry fees will be forfeited. A signed affidavit must be completed upon weigh-in of any coyote.
